**General Data Protection Regulations 2016 – Subject Access Request Form**

The documents should include your name, date of birth and current address. If you have changed your name, please supply relevant documents evidencing the change.

## **Administration fee:**

WRC's policy is not to charge for Subject Access Requests. Excessive or repetitive requests may attract a nominal administrative charge but this will be discussed with you before any costs are incurred.
